# UPDATE ON THE WORK OF OTHER ADVISORY COMMITTEES

### Purpose

1. This paper outlines issues from other advisory committees that may be of interest to ACAF.

## Advisory Committee on Microbiological Safety of Food (ACMSF)

- 2. ACMSF is scheduled to meet on 29 January 2015, and the following items are on the provisional agenda:
  - the response to the public consultation on the ACMSF report "An Update on Viruses in the Food Chain;
  - risk assessment of Salmonella from shell eggs;
  - a presentation on findings from Wave 3 of the FSA's Food and You survey;
  - the results of a microbiological survey of pre-packed ready-to-eat sliced meats at retail in UK small to medium sized enterprises;
  - food safety risk of recycled manure solids used as bedding for dairy cattle; and
  - an update on the work of the Epidemiology of Foodborne Infections Group and the ACMSF Antimicrobial Resistance Working Group.
- 3. Following the formal ACMSF meeting there will be a horizon scanning workshop on the afternoon of 29 January.

### Advisory Committee on Releases into the Environment (ACRE)

- 4. The next ACRE meeting is on 19 March 2015 when the Committee will discuss the draft report of the ACRE harm sub-group. The sub-group has been developing a framework for defining harm to ecosystems that could be used in the environmental risk assessment of genetically modified organisms.

## The Committee on Carcinogenicity (COC)

- 8. The COC last met on 13 November 2014.
- 9. The Committee continued its assessment of alcohol and cancer with reviews of the risk of breast cancer, and of colorectal cancer. It also considered a strategy paper for the calculation of burden of cancer attributable to alcohol consumption. The Committee's advice on alcohol and cancer will be published in a statement in due course.
- 10. The COC reviewed a third draft statement on vitamin E and the risk of prostate cancer and a lay version of the statement. The final statement is expected to be published in 2015. The Committee also considered drafts of two of its series of Guidance Statements: 'Alternatives to the 2-year Bioassay' and 'Hazard Assessment and Characterisation'. # The Committee on Toxicity of Chemicals in Food, Consumer Products and the Environment (COT)

12. The COT met on 9th December 2014 and the agenda included:

• first draft statement on the potential risks from hexabromocyclododecanes (HBCDDs) in the infant diet:

a. potassium-based replacements for table salt and sodium additives - additional information on hyperkalaemia.

b. first draft statement on potassium-based replacements for sodium chloride and sodium-based additives

- first draft statement on polybrominated biphenyls (PBBs) in the infant diet;
- first draft statement on the effects of soya consumption on thyroid status; and
- third draft statement on the potential risks from polybrominated diphenyl ethers (PBDEs) in the infant diet.

13. The next COT meeting will be on 3rd February 2015.

### General Advisory Committee on Science (GACS)

- 14. GACS met on 29 October 2014. This was the first meeting of the FSA's new Chief Scientific Advisor, Professor Guy Poppy. Items discussed at the meeting included:
  - Report on FSA Science;
  - FSA response to the Elliot Review;
  - FSA Science and Evidence Strategy;
  - Scientific staffing, skills and professions in the FSA;
  - Science in the Scientific Advisory Committees (SACs) (This included a presentation from ACMSF Chair Sarah O'Brien on the IID 2 attribution study); and
  - Joint GACS-SSRC working group on the use of evidence.
