- Agency science: initial views on strengths and challenges
- GACS progress to date

Science in the FSA – strengths

- Openness, transparency
- Commitment to science and evidence-based work
- Appointment of Chief Scientist and Team
- Willingness to invite and respond to challenge including from GACS
- Existing structures: Strategy; expert Scientific Advisory Committees (SACs); governance tools

Science in the FSA – challenges

- Getting the best out of the Agency's research spend
- Optimising the use of SACs
- Governance
 - developing good practice further
 - ensuring science input/feedback on how science is used to develop policy and advice
 - obtaining and using different types of evidence
 - evaluation of the assessment and use of evidence
 - Engaging with wider expertise and opinion
 - Who? Science community, industry
 - Why? Input of ideas and information, broadening the research base

GACS: progress so far (1)

- From 1st meeting (11 March 08)
 - strong commitment from members
 - robust discussion about Agency science
 - conscious of need to provide credible independent challenge
 - rapporteurs to report on Agency's own research
 - Working Group on measures of success
 - Agreed GACS Work Plan
- Panel debate (11 March 08; part of NSEW)
 - role of evidence in decisions about food
 - many suggestions about issues and governance

GACS: progress so far (2)

- 2nd meeting (29 October 08)
 - Horizon scanning identifying strategic issues, improving processes, workshop on developments in food production (picking up ideas from ACAF + SACN)
 - Performance Indicators for Agency science
 - Research in the Agency- rapporteurs' report
 - Performance of the SACs communication, openness, clarity on roles in risk assessment and risk management
 - Governance and good practice issues raised by two external reports

GACS Workplan (1)

- GO Science Review of the Agency
 Consider issues identified and Agency response
- Development of next Agency Science Strategy
 - GACS members to take part in scoping workshop, discussion at 3rd GACS meeting
- Governance
 - Review tools and procedures in light of experience and challenges
 - Uses of scientific evidence and advice
 - Relationship between risk assessment and risk management

GACS Workplan (2)

- Territories and ways of working of SACs
 - Missing or overlapping areas of expertise?
 - Facilitating interaction between SACs (Annual Conference)
- Engagement; communication; collaboration
 - College of Experts
 - Web-based tools
- Performance Indicators
 - Refine and agree tools and process for regular evaluation
