
Total feed ban



- EU ban on feeding of processed animal protein (PAP) to farmed animals.
- Introduced in 2001 reinforcing previous feed bans to control BSE (e.g. 1996 in UK).
- Contains a number of derogations e.g. feeding fishmeal to pigs/poultry; non-ruminant blood products to non-ruminants; non-ruminant blood meal to fish.

Evolution of the number of BSE cases in the EU since 2001






European Commission's TSE Roadmap 2



- Published 16 July 2010.
- Strategy paper plus annexes.
- Goal for the period 2010-2015 is to continue the review of the measures while assuring a high level of food safety.
- Stepwise approach based on scientific advice from EFSA.



European Commission's TSE Roadmap 2



Strategic Goals include reviewing certain measures of the current total feed ban when certain conditions are met.

- Consideration of lifting of the ban on the use of non-ruminant (e.g. poultry or pig) PAP in non-ruminant feed without lifting the existing prohibition on intra-species recycling subject to:
- Availability of validated analytical techniques to determine the species origin of PAP.
- ii. Correct channelling of PAP from different species.

Intra-species recycling ban



- Article 11 of Regulation (EC) 1069/2009 laying down health rules as regards animal by-products and derived products not intended for human consumption **prohibits** feeding of:
- terrestrial animals (other than fur animals) with PAP derived from animals of the same species.
- farmed fish with PAP derived from farmed fish of the same species.

Proposed partial relaxation of total feed ban

Proposed channelling controls



Draft Commission proposal SANCO/10843/2011 to establish new criteria for feeding non-ruminant PAP (exc. fishmeal) to non-ruminants:

- Slaughterhouse controls production of raw materials in approved nonruminant slaughterhouses but derogation.
- Processing plant controls production of PAP in approved single species processing plants but derogation.
- Feed mill controls production of feed in authorised single species feed mills but derogations.
- Labelling 'contains PAP derived from X shall not be fed to X'
- Transport dedicated to single species until cleaned and inspected.
- Use and storage of feed not on farms where prohibited species kept but derogation.

Status of validated analytical techniques



- Competent authority must carry out risk-based checks including testing for presence of PAP.
- The current statutory test for PAP in feed under Regulation (EC) No.152/2009 is Microscopy.
- Bovine DNA-based PCR marker validated during SAFEED-PAP. Limit Of Detection of PAP in feed is less than 0.1%.
- EURL intends to finish validating the PCR test during 2011.
- Regulation (EC) No. 152/2009 would be amended accordingly.

Assessment of risk of proposal



- SANCO/10843/2011 draws on EFSA advice (2007) that BSE risk of feeding pig PAP to poultry and vice versa is negligible.
- In 2008, SEAC provided advice on relaxation of the ban on feeding non-ruminant PAP to non-ruminants.

Impact of partial relaxation of total feed ban



- Pig and poultry PAP is a valuable protein/mineral source.
- Environmental/Sustainability Reduce dependency on imported protein (soya) and on fishmeal (aquaculture).
- Economic Impact on feed prices; New (export) markets;
 competition with third countries.
- Specific impact in UK uncertain as most PAP produced in UK is currently used in pet food or fertiliser.

Next steps...



- Further discussions on SANCO/10843/2011 throughout
 2011 in parallel with EURL validation of PCR test.
- Amendment of Regulation (EC) No.152/2009 to include validated PCR test.
- Anticipate vote on SANCO/10843/2011 at Standing Committee on Food Chain and Animal Health (subject to validation of PCR test).
- If agreed, 3 months scrutiny before entry into force (2012?)
