UPDATE ON THE WORK OF OTHER ADVISORY COMMITTEES

Purpose

1. This paper outlines issues from other advisory committees that may be of interest to ACAF.

Advisory Committee on Microbiological Safety of Food (ACMSF)

- 2. The ACMSF met on 19 January 2012. The main items discussed were as follows:
- a presentation on horizon scanning in the catering sector focussing on possible risks from changing food preparation techniques;
- a paper written by the Secretariat giving the background to the way risk assessments have been carried out by the Committee and a possible framework for undertaking risk assessments more consistently in future;
- a draft response from the Committee to the Waste & Resources Action Programme (WRAP) risk assessment on quality, safety and use of digestate in UK agriculture;
- a paper bringing the Committee up-to-date with current activities in relation to the microbiological safety of sprouted seeds, including a recent EFSA scientific opinion on this subject;
- proposals for a process for approving and updating the ACMSF work plan; and
- an update from the last meeting of the Epidemiology of Foodborne Infections Group.
- 3. The next meeting of ACMSF will be on 29 May 2012.

Advisory Committee on Novel Foods and Processes

- 4. The most recent ACNFP meeting took place on 15 February 2012. The main items of discussion were:
 - the report of the Quinquennial Review of the ACNFP;
 - review of the Open Event which took place on 24 November 2011; and
 - consideration of a European Union expert working group's report on new techniques of genetic modification (GM).

5. The next meeting of the ACNFP is scheduled for 26 April 2012.

Advisory Committee on Releases into the Environment (ACRE)

- 6. ACRE met on 9 February 2012. The main item discussed was the draft final report of ACRE's post-market environmental monitoring sub-group.
- 7. ACRE also discussed EFSA's scientific opinions on 4 food and feed applications including cultivation MON88017 maize, GA21 maize, the 2009 post-market monitoring report on MON801 maize and an updated evaluation of 1507 maize.

The Committee on Toxicity of Chemicals in Food, Consumer Products and the Environment (COT)

- 8. COT met on 7th February 2012. Items on the agenda included:
 - a presentation by the Agency's Head of Strategy and Policy Unit on 'horizon scanning';
 - use of toxicogenomics data in risk assessment;
 - COT input into Scientific Advisory Committee on Nutrition (SACN) review of complementary and young child feeding;
 - draft statement on the FSA-funded T05 research programme on phytoestrogens;
 - draft 2011 Annual Report;
 - FSA Scientific Advisory Committees (SACs) update paper for information ; and
 - update on actions taken subsequent to COT advice paper for information.

- 10. The COT is trialling an online Forum which is now available, but only to download papers.
- 11. The next meeting of the COT will be on 20 March 2012 at Aviation House.

The Committee on the Carcinogenicity of Chemicals in Food, Consumer Products and the Environment (COC)

12. The COC is current reviewing the relative vulnerability of children to asbestos, at the request of the Department for Education. It is also continuing to revise its guidance and plans to produce separate guidance

statements on different areas of carcinogenic risk assessment, as the COM has done.

The Committee on the Mutagenicity of Chemicals in Food, Consumer Products and the Environment (COM)

- 13. The next meeting of the COM will be held on 8 March 2012. Items on agenda include:
 - draft guidance statements on impurities and chlorophenols;
 - human health significance;
 - horizon scanning;
 - Annual Report for 2011 and;
 - a statement on nanomaterials and a presentation on QSARs (Quantitive Structure activity relationship).

General Advisory Committee on Science (GACS)

- 14. GACS will meet on 14 March 2012. Items on the provisional agenda for this meeting include:
 - Chief Scientist's report;
 - Science in the SACs it is hoped that Professor Peter Aggett will provide a presentation on SACN;
 - Report of the review of science governance GACS to discuss the draft conclusions/proposals from the review;
 - Quinquennial Review of ACNFP GACS to discuss responses from ACNFP and FSA to the recent ACNFP quinquennial review;
 - Quinquennial Review of GACS GACS to discuss the quinquennial review, its draft response, and FSA's response, followed by a wider discussion on priorities for GACS in the coming years; and
 - Presentation Philip Lowe (Rural Economy and Land Use Programme) on developing innovative approaches to working across disciplines and with other organisations.

Social Science Research Committee (SSRC)

15. The next SSRC meeting will be held on the 18 April 2012, in Aviation House. An agenda has yet to be finalised.
